## 7. City Administrator Report:

a. GCMP Update

Mr. Greenwood reported that the park has been a success. We are having some repairs done on the splash pad and it will be closed Monday and Tuesday, May 20-21, 2024. All the close-out documents for the park project should be ready by Friday, May 24, 2024.

## b. FLP Extension Update

The close out documents should be ready soon as well.

#### c. Richland Mall Update

The demolition continues and the developers are working on their Planned Development District.(PDD) document.

#### d. Budget

We are waiting on most of our large revenues for FY 23-24.

## 8. Finance Director Report: Monthly Financial Report

Assistant City Administrator/Finance Director Smith reported the General Fund and Hospitality Tax statements through April. Currently we are wrapping up FY 23-24 and have 67% of our budgeted revenue and are tracking along on expenditures. We are above out anticipated HTax collections for the year. ARPA funds will cover the upcoming closing out of the park project.

#### 9. Police Chief's Report:

Chief Robinson reported the April 2024 crime and traffic statistics to Council.

Front porch rollcalls are expected to begin again soon.

The speed blitz program will be scheduled soon as well.

## **10. Community Forum:**

Resident Julius Weathers stated that SC DOT did not put the speed tables back down after they repaved the road recently. Mr. Greenwood said that he spoke with SC DOT and the original speed tables were installed at the expense of MUV Fitness. If they are to be replaced, they would need to be funded and the city would have to reapply for a new encroachment permit.

Resident Nancy Brantley stated that there is a hole in the road when turning from Forest Drive onto N. Trenholm coming from Fort Jackson. Mayor Andrews said that we will look at it and make a request with SC DOT.

#### 11. Council Items:

Mayor Andrews stated that AC Flora's Men's Golf team won their 18th State Championship.
