# MINUTES OF THE FOREST ACRES CITY COUNCIL June 11, 2024

Mayor Tom Andrews, Mayor Pro-tem David Black, Council members Haskell Kibler, Ryan Newton, and Stephen Oliver were present, along with City Administrator Shaun Greenwood, Assistant City Administrator/Finance Director Andy Smith, Police Chief Don Robinson, and City Attorney Will Dillard.

#### Mayor Tom Andrews called the meeting to order at 6:00 p.m.

City Attorney Will Dillard opened the hearing at 6:10 pm stating that the purpose of the public hearing is to entertain public comments on the proposed FY 24-25 City Budget. He added that the proposed budget provides for revenues and expenditures of \$9,994,282 based on a milage rate of 52.1 mils.

With there being no questions or concerns either in favor or opposition to the FY 24-25 budget from either Council or the public, Mr. Dillard closed the public hearing at 6:11 pm.

## 4. Mayor's Issues & City Projects

- a. Responses to Community Forum Items:
  - i. Satchel Ford and Valleybrook homes

City Engineer/Building Official Keith Lindler has remained in touch with Richland County and the stop work orders have been lifted and the developer has submitted building plans for review. The surrounding residents have been notified that the city has issued a few of the building permits.

ii. Brentwood Speed tables

Administrator Greenwood said that the tables that SC DOT removed to repave must be reapplied for. A petition form has been given to the residents to begin the process. Representative Heather Bauer called the City of Columbia to see if they could offer any

assistance. The COC put the city in touch with a contractor that can put in new speed humps. Mr. Greenwood will be contacting SC DOT tomorrow. We will be reassessing where to put in new speed humps as well.

iii. Trenholm Road pothole

Mr. Greenwood said that this issue has been reported to SC DOT.

## 8. City Administrator Report:

a. GCMP update

Mr. Greenwood stated that residents are enjoying the splash pad, fishing dock, and the Farmer's Market at our new park. We are having some minor modifications and repairs completed.

- b. FLP Extension update This project is complete.
- c. Richland Mall update The demolition continues and the contractors are moving along quickly.
- d. Zoning Ordinance update The latest modules have been presented to the Planning Commission. We want to have Council's comments to the consultants in the next 30 days.
- e. Citadel and Idalia Park water fountains Kendall Adams and intern Emily Berg are working to have the fountains replaced. We are looking for a heavy duty option since the fountains are used constantly.
- 9. Finance Director Report: Monthly Financial Report

Assistant City Administrator/Finance Director Smith reported the General Fund and Hospitality Tax statements through April. Currently we are wrapping up FY 23-24 and have 74% of our budgeted revenue and are tracking along on with 88.5% in expenditures. We are wrapping up the allocation of funds for GCMP completion.

## 10. Police Chief's Report:

Chief Robinson reported the May 2024 crime and traffic statistics to Council.

Our K-9 Indy had oral surgery this week but should be back at work next week.

Council member Oliver asked why the number of traffic tickets seems to be going down every month. Chief Robinson said that shoplifting incidents are on the rise and the processing time is lengthy. Traffic accidents take a lot of time as well. Mr. Greenwood added that we are trying to develop outside the box strategies on how to address occurrences, so the officers have more time to run radar all over the city.

Mr. Oliver asked about the security camera at Willingham and Bethel Church being installed. Chief said that now that school is out there is a camera they are looking at relocating to the location.
